## Discounted tickets

To qualify for discounted tickets, please provide a photocopy of your most recent disability-related state benefit document. The document you submit should be dated from within the last 12 months and not have expired.

Please find below a list of usually accepted criteria:

- Disability Living Allowance (DLA) or Attendance Allowance
- Employment & Support Allowance for a period of at least twelve months Personal Independence Payment (PIP)
- Working Tax Credit
- (with disability element only) Constant Attendance Allowance The Independent Living Fund Disabled Student's Allowance
- Industrial Injuries Disablement Benefit War Disablement Pension
- Armed Forces Compensation Scheme (with Guaranteed Income Payment only) Vaccine Damage Payment
- Severe Disablement Allowance

This list is subject to change in accordance with the guidelines provided by the Department for Work & Pensions. The Royal Opera House reserves the right to refuse discounted tickets where it deems necessary.
